## **BURDEKIN SHOW – WEDNESDAY 26<sup>th</sup> JUNE 2019**

### **General Conditions of Contract**

**Failure To Comply With The Conditions Listed Below May Result In The Cancellation Of Your Site Rental Contract & Forfeiture Of Moneys Paid.**

**It is to be noted that Space is let, subject to the Rules of the QUEENSLAND CHAMBER OF AGRICULTURAL SOCIETIES INC. and the Rules of the AYR PASTORAL AGRICULTURAL & INDUSTRIAL ASSOCIATION INC., including any special regulations that may apply.**

1. **STALL REGULATIONS:** All stalls must be constructed & maintained in accordance with all appropriate departmental regulations. It is the responsibility of the Applicant to see that all permits and inspections have been obtained & carried out. All Certificates must be presented when requested by the Ayr P.A. & I. Assoc Inc.
2. **SUB-LETTING:** The allocated Site is to be used only and solely for the purpose specified on the Application and by the person/Firm to whom it has been allocated. **No Sub-letting** is permitted without the permission of the Ayr P.A. & I. Assoc. Inc.
3. **SITE & SELLING RESTRICTIONS:** The Exhibitor/Lessee must confine their business to the purpose accepted on the Site Application. No selling, canvassing, hawking, or distribution of printed or any other matter will be permitted outside the area allocated. Canvassing off your allocated site will result in closure of your site and forfeiting of all monies paid. The Ayr P.A. & I. Assoc Inc. reserves the right to forbid the sale of any line for which specific application has not been made. ALSO each stall holder **must at all times display in full view of the public a Price List** for all services provided by the stall holder.
4. **ADVERTISING SIGNS:** The display of approved advertising signs of any description is restricted to the area occupied by the Exhibitor/Lessee. No permanent signs can be erected.
5. **EXHIBITOR/LESSEE CONDUCT:** The Exhibitor/Lessee is to conduct themselves in an orderly and respectful manner at all times while they are on the Show Grounds. Alcoholic beverages must not be consumed on Sites by the Exhibitor/Lessee and/or Workers during show hours.
6. **OFFENSIVE MATERIAL/LITERATURE:** Any authorized member of the Ayr P.A. & I. Assoc Inc. shall have the right to enter the Sites and remove any article, sign, picture or printed matter, which **in their opinion** may cause offence to the Public or Officials/Members of the Ayr P.A. & I. Assoc Inc.
7. **DISPLAY FASTENINGS:** Under no circumstances shall an Exhibitor/Lessee excavate, dig, or place pegs in his area without first obtaining the authority of the Ayr P.A. & I. Assoc Inc. The securing of any floor coverings is to be with tape only.
8. **DISPLAY LAYOUTS:** The Ayr P.A. & I. Assoc Inc. undertakes to rent the said Site in its present condition. All subsequent plumbing, carpentry and electrical work will be the responsibility of the Exhibitor/Lessee. All erections are to be of a temporary nature and must be completely removed at the conclusion of the Show.
9. **SOUND SYSTEMS:** Any/all audio or visual sound equipment must be operated at a volume that does not disturb other Exhibitors/Lessees, Show Patrons or the General Public. The Ayr P.A. & I. Assoc Inc. is empowered to remove any systems upon the receipt of a legitimate complaint.
10. **ELECTRICITY:** **ONE [1]** power outlet is provided. Any excess power usage will be assessed and payment will be required. All leads must be **Tested and Tagged** and be **clear of the ground** or **buried** and **must not impede** the flow of pedestrians and vehicles.
11. **RUBBISH DISPOSAL:** Bins are provided and each Exhibitor/Lessee is responsible for the cleanliness of their individual Site for the duration of their stay on the said Association's Grounds. If environmentally hazardous items are left on site, a **fine of \$150.00 per item** will be issued to the offending Exhibitor/Lessee. Your actions will also be disclosed to other Queensland Show Societies

## General Conditions of Contract (Cont'd)

12. **SITE ALLOCATIONS:** The Ayr P.A. & I. Assoc Inc. has at all times the **final say** on all **site allocations** & no further matters will be entered into. Should circumstances dictate, the Ayr P.A. & I. Assoc Inc. reserves the right to **cancel or alter** any Site, or position of any Space, whether previously held by Exhibitor/Lessee or not.
13. **SITE CANCELLATION:** If for any reason whatsoever, an Exhibitor/Lessee cancels their site, [all cancellations must be in writing and addressed to the Secretary of the Association]. A Cancellation Fee may apply. This Fee would depend upon circumstances and timing.
14. **LOSS OR DAMAGE:** The Ayr P.A. & I Assoc Inc. will not under **any circumstances** be held **responsible for any loss or damages to stock in trade, etc. or any part thereof** of any Exhibitor/Lessee from **any cause whatsoever**.
15. **INDEMNITY:** The Ayr P.A. & I Assoc Inc. will not be responsible for **any accident** which may be caused through or by the Exhibitor/Lessee, or which may happen in connection with their business & the **Exhibitor/Lessee shall save the Ayr P.A. & I. Assoc Inc. harmless & indemnify it** against **any legal proceedings** arising from every such accident.
16. **PUBLIC LIABILITY:** Details of the current **Public Liability Policy** held by each Exhibitor/Lessee **must be furnished** with the respective **Space Contract and Request for Space Forms**. The **Indemnity** level should be a **minimum of \$10 million**. Without proof of current Public Liability coverage held by Site Applicant, the Ayr P.A. & I. Assoc Inc. will reject any such Site application/request. Your details of current Public Liability Insurance provided with your application will be respected and treated as Private and Confidential information.
17. **WORKPLACE HEALTH & SAFETY REGULATIONS:** Written and signed assurance is required from you that any temporary structures, vans, equipment etc. and any activity that takes place on or adjacent to your Site, complies in all aspects with Workplace Health & Safety Legislation. This includes but is not limited to testing and tagging of all electrical equipment and fitting of Earth Leakage Detection devices if equipment is not double insulated. **A written report of all accidents and/or dangerous occurrences must be provided to the Ayr P. A. & I. Assoc Inc., by you the Exhibitor/Lessee.**
18. **SETTING UP:** Is permitted from **Tuesday 25<sup>th</sup> June 2019**, the day prior to the start of the show unless prior arrangements have been made with the secretary/site coordinator.
19. **OPERATING TIMES:** Displays/stalls are to be **operating by 9.30 am Wednesday 26<sup>th</sup> June 2019**. Space whether paid for or not will be re-allocated after this time, if the Show Office is not notified of any delays.
20. **DISMANTLING:** **Displays, stands or fixtures must not be dismantled, or goods and materials removed, prior to 10.00 pm, Wednesday 26<sup>th</sup> June 2019.**
21. **CAMPING:** Is permitted at the Mackenzie Street end of grounds only. Showers & toilets are provided in the camping area. All enquiries & directions are available from the Show Office. **Camping is an additional charge and not covered in your Space Rental charges.**
22. **VEHICLES:** Will only be allowed into display area prior to 9.30 am on show day for the purposes of unloading of goods. **Vehicles carrying supplies are then not permitted to remain in this area** unless the vehicle is deemed part of the display. All vehicles must then be parked outside the grounds or in the camping area.
23. **GATE PASSES:** **Two (2) Gate Passes** are issued for each Site/Display. It is the responsibility of the Stall Holder to obtain these Gate Passes from the Secretary's Office on arrival and if required, to purchase additional Gate Passes to cover the number of workers needed for said Site. **Additional Passes cost \$10.00 each**. This Pass will admit the holder into the grounds. A Gate Pass must be shown to re-gain entry. No admittance into the grounds will be allowed without a Gate Pass.
24. **ALTERATIONS:** The Ayr P. A. & I. Assoc Inc. reserves the right to **alter** this **General Conditions of Contract** at any time and without further reference to Site-holders /Lessee.
